

FINAL JUDGMENT ON DISSOLUTION OF MARRIAGE

This cause came before this Court for a non-jury trial on only the First Cause of Action on Petition for Dissolution of Marriage without Dependents or Children and Additional Circuit Civil Causes of Action. The Court, having reviewed the file, heard testimony and considered the evidence, makes these findings:

1. The Court has jurisdiction over the subject matter and the parties.
2. At least one party has been a resident of the State of Florida for more than 6 months immediately before filing the Petition on November 21, 2008.
3. The parties have no minor children in common.
4. The Petitioner/Wife is not pregnant.
5. The marriage between the parties is irretrievably broken.
6. A default was entered against the former husband on January 15, 2009. The former husband filed a motion to set aside the default on February 13, 2009, the court heard said motion on April 21, 2009 and motion was denied.
7. The parties own a Florida business International Motorsports Academy, Inc. together.

8. The husband has sold, dissipated or absconded numerous assets of International Motorsports Academy, Inc.
9. The husband pled "no contest" and was adjudicated Guilty to the charge of Felony Domestic Strangulation of the Wife/Petitioner on March 10, 2009.
10. As part of his sentence, the husband relinquished his Green Card and voluntarily departed the United States for his native Canada.


Therefore, it is **ORDERED** and **ADJUDGED**:


- A. By way of default judgment, the Petitioner/Wife prevailed on the First Cause of Action and the remaining sixteen (16) causes of action in this case.
- B. The marriage between the wife and husband is hereby dissolved and the parties are restored to the status of being single.
- C. The wife's name is hereby restored to Jennifer Lee Stringer.
- D. Any tangible or intangible assets and items currently in possession of either party shall hereby belong to that party.
- E. Petitioner/Wife's interest in International Motorsports Academy, Inc. is hereby awarded to the Petitioner/Wife.
- F. Husband's interest in International Motorsports Academy, Inc. is hereby awarded to the Petitioner/Wife. Husband shall hold Petitioner/Wife harmless and indemnify her for any debts or liabilities of said entity.
- G. The International Motorsports Academy, Inc. corporation, corporate name, domain name of www.imaracing.com, email accounts, trademarks, logo and any remaining assets are hereby awarded to Petitioner/Wife.

H. The Court reserves ruling with respect to Petitioner/Wife's award of attorney fees and costs.


I. The Court reserves jurisdiction of this cause for enforcement or modification of its Order.


