Place of Existence:

This Corporation shall have corporate existence commencing on the
27th Day of October, 2000

ARTICLE III

Powers:

This Corporation is organized for the purpose of transacting any and
all lawful business.

ARTICLE IV

Power:

The Corporation shall have the power:

(a) To do all things necessary for the corporate aims.

- (b) It makes and/or awards compensation or benefits to the corporate bonds in all actions or proceedings;
- (c) It places on a corporate seal which may later be transferred, and it uses the seal by causing it to be affixed to documents it has prepared, drafted, or it may obtain others to reproduce;

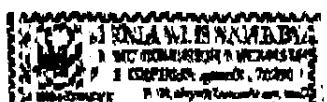
