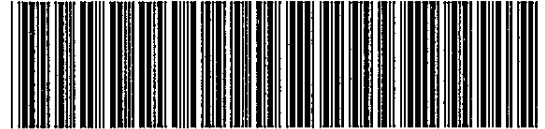

ARTICLE I - NAME

The name of this Corporation is ROSA ANTOJITOS MEXICANO, INC.

on September 22, 2005.


