THE UNDERSIGNED, Michele M. Hickey, president of Hickey and Associates, PA, a Florida corporation (the "Corporation"), hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation pursuant to Chapter 607.1006, Florida Statutes.

1. The name of the corporation shall be Hickey and Associates, PA
2. Article I of the Articles of Incorporation is hereby amended in its entirety, as follows:

ARTICLE I – NAME OF CORPORATION
