ARTICLES OF INCORPORATION

ARTICLE I- NAME

The name and address of this corporation is as follows:

A.M.A. INVESTMENT GROUP, INC. 9513 SW 72 Street Miami, Florida 33173

ARTICLE II- DURATION

The duration of this corporation shall be perpetual commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III~ PURPOSE

This corporation is organized for the following purposes:

SECTION 1. To issue personal automobile insurance coverage.

SECTION 2. In general to have and exercise any and all powers that corporations have and may exercise under the laws of the State of Florida and as the same may be amended, except such powers as are inconsistent with the express provisions of these Articles.

SECTION 6. To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.

SECTION 7. To lend money to, and use its credit to assist its officers and employees in accordance with Section 604.141, Florida General Corporation Act.

SECTION 8. To purchase, take, receive, subscribed for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or

individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, municipality or of any instrumentality thereof.

SECTION 9. To make contracts and guarantees and incor liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.

SECTION 10. To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

SECTION 11. To conduct its business, carry on its operations and have offices and exercise the powers granted by this Act within or without this State.

SECTION 12. To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.

SECTION 13. To make and alter by-laws, not inconsistent with its Articles of Incorporation, or with the laws of this State, for the administration and regulation of the affairs of the corporation.

SECTION 14. To make donations for the public welfare or for charitable, scientific, or aducational purposes.

SECTION 15. To transact any lawful business which the Board of Directors shall find will be in aid of governmental policy.

SECTION 15. To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers. and employees and for any or all of the directors, officers, and employees of its subsidiaries.

SECTION 17. To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other enterprise.

SECTION 18. To have and exercise all powers necessary or convenient to effect its purpose.

SECTION 19. To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.
