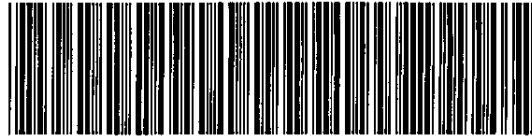



Dissolution was authorized on March 20, 2007. Dissolution was approved by the Shareholder. The number of votes cast for dissolution was sufficient for approval.

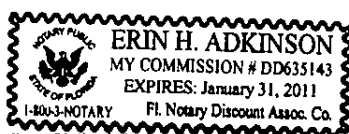


