Articles of Incorporation of America's Check Cashing Company *Inc.*

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act does hereby the following Articles Of Incorporation :

Article One

The name of the corporation is **America's Check Cashing Company *Inc.***

Article Two

The duration of the Corporation is perpetual.

Article Three

The general purposes for which the Corporation is organized are:

1. *is to provide financial services including but not limited to public check-cashing, electronic deposits, money orders, tax preparation, wire transfers, phone cards, and other financial services and products.*
2. Property management including management and ownership of real and personal property for businesses and residences, corporations and individuals.
3. To conduct its business, caring on its operations and have offices and exercise the powers granted by this act or without this State. To transact any other lawful business for which the corporation may be incorporated under the Florida General Corporation Act or engage in any other trade or business which may be in the opinion of the Board of Directors of the Corporation , be advantageously carried on in the connection with or auxilliary to the foregoing business.

Article Four

1. The aggregate number of shares which the Corporation is authorized to issue is seven thousand five hundred (7,500). Such shares shall be of single class and shall have par value of one dollar.

2. To preferences , limitation or relative rights , other than those provided by law, shall exist in respect of the shares of the Corporation or any of the holders thereof.
