ARTICLES OF INCORPORATION

OF

MOBILE MARINE DIESEL, INC.

The undersigned incorporator hereby makes, subscribes to, acknowledges, and causes to be filed these Articles of Incorporation (hereinafter these "Articles") for the purpose of incorporating a corporation for profit under the Florida General Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I (Name of Corporation)

The name of the corporation is Mobile Marine Diesel, Inc. (the "Corporation").

ARTICLE II (Corporate Existence)

The time and date on which corporate existence of this Corporation shall begin is 12:01 A.M. (local time) on September 28, 2005, and the Corporation shall have continuous and perpetual existence thereafter.

ARTICLE III (General Purpose of Corporation)

The general purposes for which the Corporation is initially organized are as follows:

To operate a diesel marine business and to transact any other lawful business for which Corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV (Authorized Shares, Par Value)
