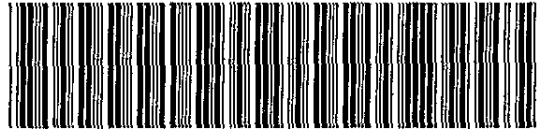

ARTICLE I. NAME

The name of this corporation is HAPPYGROVE CORP.


