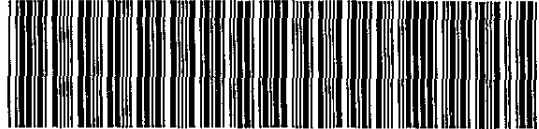

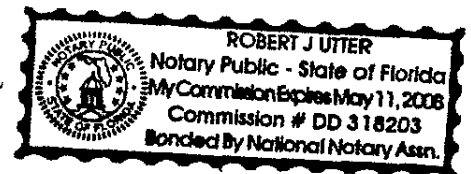




Consent of Appointment by the Registered Agent
