FIRST The name of this corporation is Beverly S. Campbell, P.A.

SECOND. Its registered office in the State Of Florida is to be located at 25212 Croom Road, Brooksville, Florida 34601, County of Hernando. The registered agent in charge thereof is Beverly J. Campbell, 25212 Croom Road, Brooksville, Florida 34601.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted, and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.

"The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law Of Florida." The specific nature of this business is real estate sales.

FOURTH. The amount of the total authorized capital stock of this
