ARTICLES OF INCORPORATION OF  
DAVID R. COYNE ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of Corporation is: David R. Coyne Enterprises, Inc.

Article 2. Duration. The duration of this Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are:

- A. To engage in and transact any lawful business for which Corporations May be incorporated under the Florida general Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation necessary or desirable in order to accomplish them.


