

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: PAT RALSTON ENTERPRISES, INC. The principal place of business will be 4820 Venetian Blvd., N.E., St. Petersburg, FL 33703.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
