- 1. The name of the Corporation shall be: AG DESIGN GROUP, INC.**
- 2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$1.00 per value.**
- 3. The street address and county of the initial principal office of the corporation is: 13428 SW 62 St., Suite 1101 Miami, FL 33183, Miami-Dade County and the name of the initial register agent at this address is: Hector A. Gonzalez**
- 4. The number of the director constituting the initial Board of Director shall be one director and the name and address of the person who is to serve as director until the first meeting of shareholders or until their successors are elected and qualified is:**

- 5. 
