

ARTICLES OF INCORPORATION OF



BLUE LAKE CITRUS PRODUCTS, INC.

ARTICLE I. - NAME

The name of the corporation is **BLUE LAKE CITRUS PRODUCTS**, **INC.** The address of the principal office of this corporation shall be 500 Avenue R, S.W., Winter Haven, Florida 33880, and the mailing address shall be Post Office Box 900, Winter Haven, Florida 33882.
