ARTICLES OF INCORPORATION OF DENTAL SCREENING, INC.

ARTICLE I - NAME

The name of this Corporation shall be: DENTAL SCREENING, INC.

ARTICLE II - COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filling of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

If this corporation fails refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

On the death of any shareholder, this corporation shall have the right to purchase any shares of capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.


