ARTICLES OF INCORPORATION  
OF  
INDX DESIGNS, INC.

ARTICLE I

The name of this corporation is INDX DESIGNS, INC. (hereinafter called the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1801 North Andrews Avenue, Pompano Beach, Florida 33069.

ARTICLE III

This Corporation is authorized to issue an aggregate total number of One Hundred (100) shares, all of which shall be designated as Common Stock having a par value of \$.01 per share.

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of the persons entitled to vote on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE V

ARTICLE VI

The Corporation's Board shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.


