ARTICLES OF INCORPORATION

ARTICLE I - Name

The name of this corporation is FOAM INNOVATIONS, INC.

ARTICLE II - Purpose

1. This corporation is organized for the purpose of transacting any and/or all lawful business including, but not limited to, conducting the specific business of the operation of foam cushions, mattresses, etc. and all other related business matters.

2. To act on its own behalf in all legal or equitable proceedings or suits.
