ARTICLES OF INCORPORATION

OF

JOSEPH T. JOWDY, P.A.

The undersigned desiring to form a corporation under the virtue of the laws of the State for Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, states as follows:.

ARTICLE I. NAME

The name of this corporation shall be:

JOSEPH T. JOWDY, P.A.

ARITCLE II. PURPOSE OF THE CORPORATION

The objects and purpose of the corporation and the general nature of the business or businesses to be transferred shall be:

- To engage in any lawful activities or business permitted under the laws of the United
 States and of the State of Florida.
- 2) To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- To borrow money of any person, firm or corporation; to issue bonds, debentures or obligations of this corporation from time to time for any of the objects or purposes of the corporation, and to same by mortgage, pledge or any other lawful means.
