ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SOUTHERN HVAC INC.

Pursuant to the Provision of Section 607.1006, Florida Statutes, SOUTHERN HVAC, INC., a Florida Corporation for Profit adopts the following amendments to its Articles of Incorporation:

ARTICLE IV - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is 7,000 shares of common stock, each having a par value of \$1.00.
