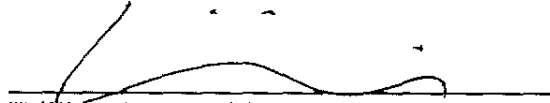
ARTICLE 10. - CUMULATIVE VOTING

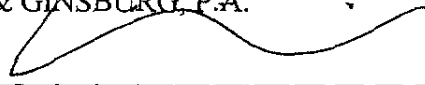
