ARTICLE I.-NAME

The name of the corporation is:

The general nature of the business to be transacted by this corporation shall be: HEALTH SPA SERVICES

This Corporation shall have ONE (1) directors initially.  
The number of directors may be increased or decreased  
from time to time in such manner as may be prescribed by the  
By-Laws, but shall never be less than one (1). The Corporation  
shall indemnify and hold harmless each person who shall  
serve at any time hereafter as a director or officer of the  
corporation, and any person who serves at the request of  
this corporation, as a director or officer of any other corporation,  
from and against any and all claims and liabilities to which  
such person shall become subject by

reasons of his having heretofore of hereafter being a director or officer the corporation, or by reason of any action alleged to have been heretofore or hereafter taken or omitted by him as such director or officer, and shall reimburse each such person for all legal and other expenses reasonably incurred by him in connection with any claim or liability provided that no person shall be indemnified against, or be reimbursed for, any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or willful misconduct in the performance of his duties.

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled nor shall anything herein contained restrict the right of the corporation to indemnify reimburse such person in any proper case even though not specifically herein provided for.

No contract or other transaction between this corporation and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise

benefits provided thereunder.




#### ARTICLE XI.- PRE-EMPTIVE RIGHTS




