Name**

**ARTICLE III**  
**Purpose**

To engage in any activity or business lawful under the laws of the state of Florida or the United States of America.

**ARTICLE IV**  
**Capital Stock**

This Corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value, common stock.

The shares of this Corporation are not to be divided into classes.

This Corporation is not authorized to issue shares in series.

**ARTICLE V**
