The undersigned subscriber of these Articles of Incorporation, competent to contract, hereby associates and forms a corporation under the laws of the State of Florida.

Article I

The name of this corporation is: William Reese, P.A. The corporate mailing address is 314 Petronia Street, Key West, FL 33040.

Article II

The general nature of the business to be transacted by this corporation is to engage in real estate purchases, sales, development and marketing and/or any other lawful purpose. It shall have every corporate power granted by the Florida legislature.
