I am writing this letter at the direction of and on behalf of Melissa G. Dovey, Director and President of the referenced Corporate entity. In your referenced letter you indicate that Ms. Dovey should send in the late fee assessed of \$ 400 for not filing the annual report on a timely basis.

As the registered agent for this Corporation as well as the preparer of the tax returns for Ms. Dovey, I always check prior to the filing of the annual federal and state corporate tax return whether the client has filed the annual report with your division for the current year. I found that Ms. Dovey did not file it, I instructed her to download the form off of your web site and file the report as soon as possible as the time to file on a timely basis had already expired. At this time, I showed Ms. Dovey a copy of the postcard received by another client to determine if this notification was already received. She informed me that such notice was not received and I informed her that there was a location to my knowledge on the annual report form to indicate this fact.

Upon my review of the signed form that you returned to Ms. Dovey of the annual report form submitted, a copy of which I have enclosed, I fail to see any place to notate that the original notification to file this form was not received by the corporate officer.

Accordingly, I respectfully request that your office waive the penalty assessment in the current case.
