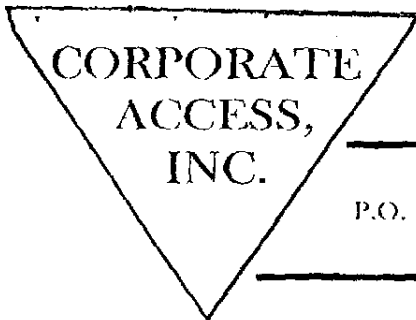

Bylaws


