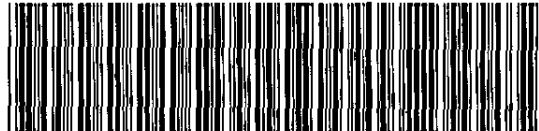

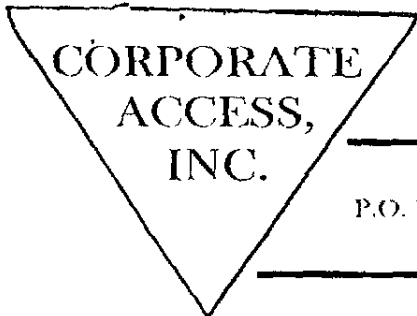

Bylaws




