

ARTICLES OF INCORPORATION OF Harrison Hair, Inc.

ARTICLE I - NAME OF CORPORATION

The name of this corporation is Harrison Hair, Inc.

ARTICLE II - PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.
