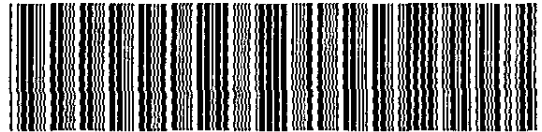

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the corporation shall be **Bradley's Well Service, Inc.**

**ARTICLE II  
PRINCIPAL OFFICE**

The principal place of business and mailing address shall be 3804 West Blount Street, Pensacola, Florida 32505.

**ARTICLE III  
PURPOSE**

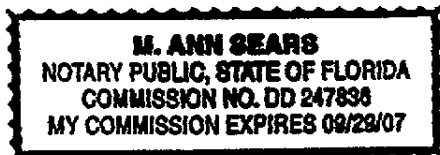
