

## ARTICLES OF INCORPORATION OF BRADLEY'S WELL SERVICE, INC.

CIVELESS IN CHEST OF 2: 49

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the corporation shall be Bradley's Well Service, Inc.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address shall be 3804 West Blount Street, Pensacola, Florida 32505.

#### ARTICLE III PURPOSE
