**ARTICLES OF INCORPORATION**  
**OF**

The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract, subscribe to and form a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is: **RJG & STAR ENTERPRISES, INC.**

**ARTICLE II - NATURE OF BUSINESS**

The corporation may engage in any activity of business permitted under the laws of the United States and of this State. These activities may include, but are not limited to the operation of the following business:

- a) to engage in the business of record production, promotions, distribution, performance, and performance bookings, and all other activities associated with the foregoing, as well as retail and wholesale sales, and investments, for any person, firm, association or corporation, without restriction in this State and any other state of the United States.

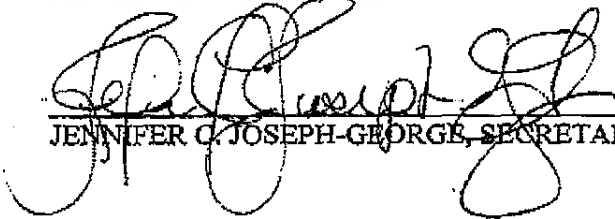

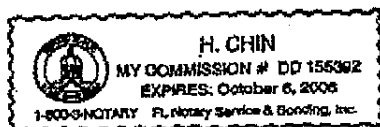
