ARTICLES OF INCORPORATION

ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS:

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on are: SALES AND DISTRIBUTION OF GIFTS, HELP PEOPLE INTERESTED IN THIS TYPE OF BUSINESS GET STARTED.

And in general to carry on any business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of the properties.
