ARTICLES OF INCORPORATION OF WINE EXPRESS, INC.

EFFECTIVE DATE 10-15-05

ARTICLE I

The name of the Corporation is WINE EXPRESS, INC.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
