Francisco J. Gutierrez is hereby *deleted* as Director and Vice President of the Corporation.

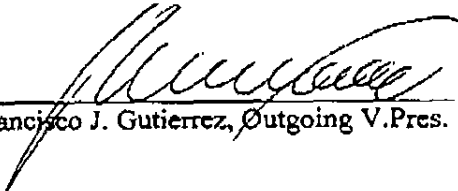
