# ARTICLES OF INCORPORATION

## ARTICLE I

Name. The name of the Corporation is THOMPSON AIRE, INC. (the "Corporation").

#### ARTICLE II

Principal Office and Mailing Address. The street address of the principal office and the mailing address of the Corporation is 13825 Avalon Road, Winter Garden, Florida 34787-9749.

## ARTICLE III

Business Purpose. This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE IV

<u>Capital Stock.</u> The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

#### ARTICLE V

Term of Existence. The Corporation shall have perpetual existence.

#### ARTICLE VI
