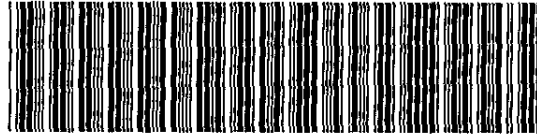

OF

ARTICLE I- CORPORATE NAME

THE NAME OF THE CORPORATION IS LORD & HOPE ENTERPRISES, INC.

ARTICLE II - DURATION

THIS CORPORATION SHALL COMMENCE ON THE DAY OF FILING AND SHALL EXIST PERPETUALLY UNLESS DISSOLVED ACCORDING TO LAW.

ARTICLE III - PURPOSE


