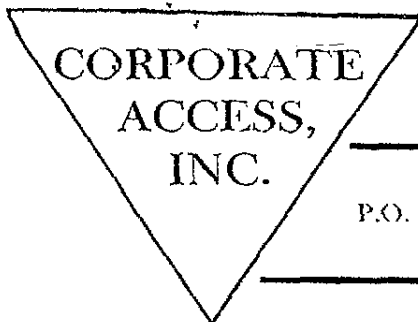

**Article I**


#### **Article VIII**


