

ARTICLES OF INCORPORATION OF ALLEN R. BENNETT CONSULTING, INC.



The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1. NAME
