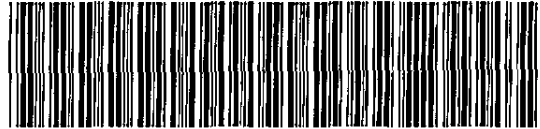





This corporation is authorized to issue 100,000 shares of no par value common stock, all of one class and series.



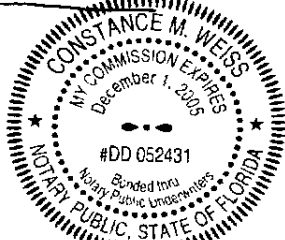
