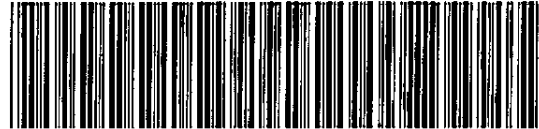

**ARTICLE I**

**Name**

**Initial Board of Directors**



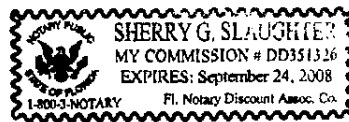
