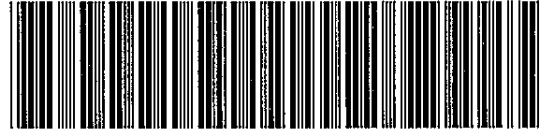

ARTICLE I

Name and Duration

The name of the company is 4@ngeles, Corp. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 6860 SW 16 Terrace, Miami, FL 33155.

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 12225 SW 129 CT. Miami, FL 33186. The name of the registered agent at such address is Angel Adrianzen.

ARTICLE IV

Corporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.
