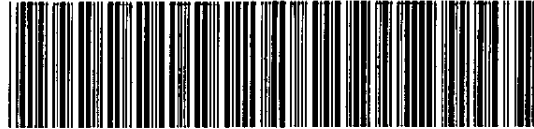

ARTICLE ONE

The name of this corporation is R. WAY CONSTRUCTION, INC. and the mailing address of the corporation shall be 10320 Wood Ibis Avenue, Bonita Springs, Florida 34135.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.


