ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is The Law Offices of Rachel Louise Howie P.A.

ARTICLE II

The existence of the Corporation shall begin on October 12, 2005.

ARTICLE III

The Corporation is established as a professional association providing legal services.


