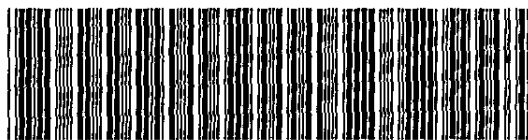

ARTICLES OF INCORPORATION
OF
CHAPTER ONE JWM *INC*

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

The period of its duration is perpetual. Corporate existence shall begin on the date of issuance of the Corporate charter.

The purpose of the corporation is: to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property,, and services, of every class, kind, and description, to lend money, to purchase or otherwise deal in commercial paper, including retail installment paper, and to do all things which could be done by a Corporation for profit under the laws of Florida, except that this Corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

The aggregate number of authorized shares is Five Hundred (500) of common stock.

The amount of capital with which this corporation shall begin business is Five Hundred Dollars (\$500.00).

Cumulative voting of shares of stock is authorized.

Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: approved by joint meeting of Board of Directors & share holders.

Provisions for regulating the internal affairs of the corporation are in the manner provided by law: Each amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

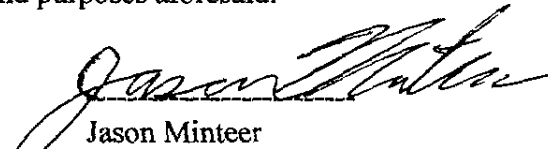

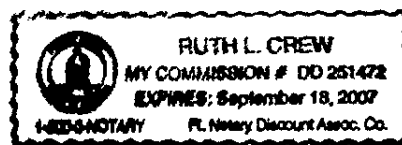

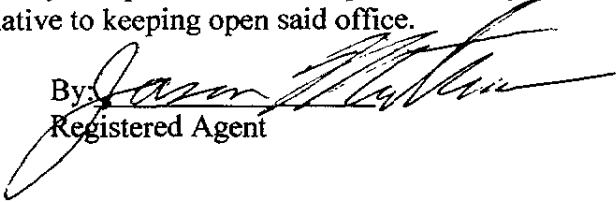
