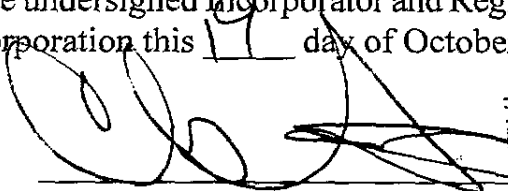

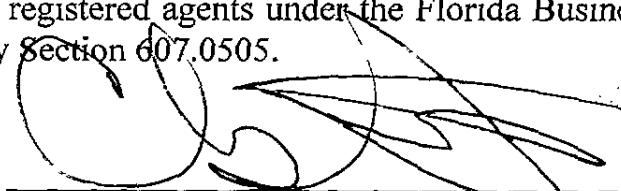
### ARTICLE IX INDEMNIFICATION
