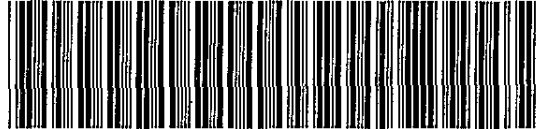

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of **THE VINE INVESTMENTS, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is **THE VINE INVESTMENTS, INC.**

**ARTICLE II. ADDRESS**

**ARTICLE III. COMMENCEMENT OF EXISTENCE**


#### ARTICLE VIII. BYLAWS


Pursuant to Chapter 48.091, Florida Statutes, the following is submitted:
