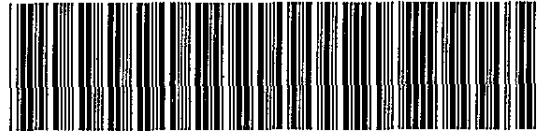

ARTICLE I

The name of this corporation is Competition Contracting.Com, Inc.




