THE GENERAL NATURE OF BUSINESS TO BE TRANSACTED BY THIS CORPORATION IS AS FOLLOWS:

SECTION 1 TO ACT AS: MINORITY BUSINESS ENTERPRISES CORP.

SECTION 2 TO PROMOTE, ORGANIZE, PLAN AND CONDUCT TRIPS, TOURS, AND EXCURSION BY RAILROAD, STEAMSHIP, MOTOR VEHICLE, OR AIRCRAFT, FOR INDIVIDUAL OR GROUP OF INDIVIDUAL TO ANY PART OF THE WORLD TO PROVIDE TRANSPORTATION OF INDIVIDUAL OR GROUP IN CONNECTION WITH THE CONDUCT OF A GENERAL TRAVEL AND TOURIST AGENCY, AND TO PROVIDE OR PROCURE HOTEL AND OTHER ACCOMMODATIONS FOR THE COMFORT, CONVENIENCE AND

ENTERTAINMENT OF INDIVIDUAL OR GROUPS. TO FURNISH GUIDES, COURIERS, ASSITANTS AND INTERPRETERS, TO PROCURE AND SELL TRANSPORTATION TICKETS ON RAILROAD, STEAMSHIPS, MOTOR VEHICLE AND AIRCRAFTS, TO ACT AS REPRESENTATIVE OF STEAMSHIP, RAILROAD AND OTHER COMPANIES DEVOTED TO THE TRANSPORTATION AND CARRIAGE OF PASSENGER AND FREIGHT, IN THE SALE OF TICKETS.

SECTION 3 TO ACQUIRE, OWN, HOLD, IMPROVE, DEVELOP, OPERAT, EXPLOIT, SELL, CONVEY, ASSIGN, LEASE, EXCHANGE, TRANSFER, DISPOSE OF PLEDGE, MORTGAGE, CREATED SECURITY INTEREST IN, DEAL IN AND LOAN OR BORROW MONEY UPON, ALONE OR IN CONJUNCTION WITH OTHERS, REALLAND PROPERTY, TANGIBLE AND INTANGIBLE OF EVERY KIND, CHARACTERS AND DESCRIPTION OF ANY INTEREST THEREIN, AND ALL KINDS AND FORMS OF SECURITIES, SHARES OF CAPITAL, STOCK, SCRIP, BONDS, DEBENTURE, COUPONS, MORTGAGE, NOTES, BILLS OF EXCHANGE, ACCEPTANCE, ASSIGMENTS, ACCOUNTS FEES, EVIDENCES OF INDEBTEDNESS, OBLIGATION, TRUST CERTIFICATES, INTERIN RECEIPTS WARRANTS AND CERTIFICATES ISSUED OR CREATED BY OR BEING CLAIMS AGAINST ANY CORPORATION ASSOCIATION, PARTNERSHIP SYNDICATE, ENTITY OR PERSON OR GOVERNMENTAL, MUNICIPAL, OR PUBLIC SUBDIVISION, DISTRIC, OR AUTHORITY.

SECTION 4 TO CONDUCT BUSINESS IN HAVE ONE OR MORE OFFICES IN, AND BUY, HOLD, MORTGAGE, SELL CONVEY, LEASE OR OTHERWISE DISPOSE OF REAL AND PERSONAL PROPERTY, INCLUDING FRANCHISES PATENTS, COPYRIGHT, TRADEMARK, AND LICENSES IN THE STATE OF FLORIDA AND IN OTHER STATES AND COUNTRIES.

SECTION 5 TO CONTRACT DEBTS AND BORROW MONEY, ISSUED AND SELL OR PLEDGE BONDS, DEBENTURES, NOTES AND OTHER EVIDENCES OF INDEBTEDNESS, AND EXECUTE SUCH MORTGAGES, TRANSFERS OF CORPORATE PROPERTY, OR OTHER INSTRUMENTS TO SECURE THE PAYMENT OR CORPORATE INDEBTEDNESS, AS REQUIRED.

SECTION 6 TO PURCHASE THE CORPORATE ASSETS OF ANY OTHER CORPORATION AND ENGAGE IN THE SAME OR OTHER CHARACTERS OF BUSINESS...

SECTION 7 THIS CORPORATION SHALL HAVE ALL THE GENERAL POWERS TOGETHER WITH ALL THE ASSITIONAL AND SPECIFIC POWERS GRANTED BY THE LAWS OF THE STATE OF FLORIDA AS WELL AS ALL IMPLIED POWERS IN CARRYING OUT THE FOREGOING EXPRESS PURPOSES.
