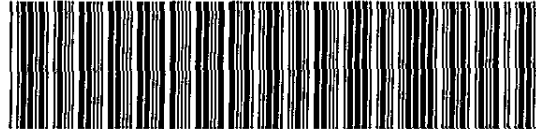

THE UNDERSIGNED, being the original incorporator of a corporation under the Florida General Corporation Act, and all other applicable Florida Statutes, I hereby adopt and ratify the following Articles of Incorporation.

1. **Corporate Name and Principal Mailing Address.** The name of this corporation shall be **NOT JUST COFFEE!, INC.** The principal mailing address for the corporation is **2450-1 S.R. 16, St. Augustine, Florida 32084.**

2. **Duration.** This corporation shall be perpetual in duration and shall not cease operation or its existence unless involuntarily dissolved by the Secretary of State of the State of Florida, or voluntarily dissolved by the incorporator or the incorporators' successors.

3. **Purpose.** The purpose of this corporation, through its incorporator and her successor, shall be engaged in any legal activity, perform any task, operate any business, or do any thing that may be permitted under the laws of the United States of America and the State of Florida.

4. **Board of Directors.** This corporation shall have two (2) directors initially; however, the number of directors may be either increased or decreased from time to time by amending the By-Laws of the corporation as provided therein, and in the manner allowed by law, but in no event shall the total number of Board of Directors of this corporation, at any time, be less than one (1). 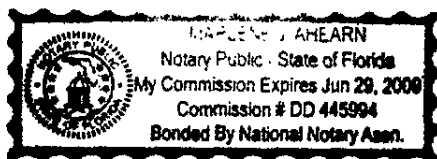

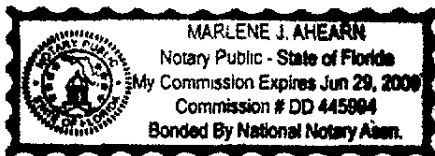
