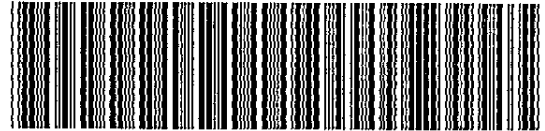

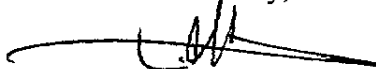

CORPORATE NAME

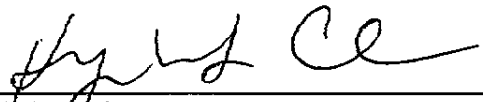

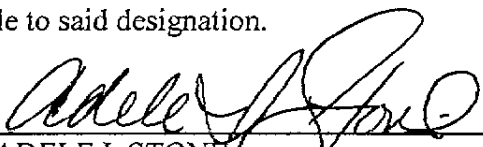
